No. 16/26/2011-3 Env.—In exercise of the powers conferred by Sub-rule (1) read with Sub-rule (2) of rule 8 of the Chemical Accidents (Emergency Planning, Preparedness and Response) Rules, 1996 the Governor of Haryana hereby constitutes the District Crisis Group to be the apex body in the Palwal District to deal with major chemical accidents and to provide expert guidance for handling chemical accidents and for performing functions mentioned in the said rules. The District Crisis Group shall comprise the following :—

Functions of District Crisis Group

- (a) Assist in the preparation of the district off-site emergency plan.
- (b) Review all the on-site emergency plans prepared by the occupier of Major Accident Hazards installation for the preparation of the District off-site emergency plan.
- (c) Assist the District Administration in the management of chemical accidents at a site lying within the District.
- (d) Continuously monitor every chemical accident.
- (e) Ensure Continuous information flow from the District to the Centre and State Crisis Group regarding accident situation and mitigation efforts.
- (f) Forward a report of the chemical accident within fifteen days to the State Crisis Group, and
- (g) Conduct atleast one full scale mock drill of a chemical accident at a site each year and forward a report of the strength and the weakness of the plan to the State Crisis Group.
